

UPDATES IN 4.0

We've made a couple of updates that we think you'll like. Similar to our visa cases, when you start a global assessment we'll ask for some initial details and you'll then be presented with a travel questionnaire. Upon completion of the questionnaire, a preliminary assessment is created and saved for that employee. This means you can return at a later time to edit the assessment or send for expert review. Global assessment is accessed by clicking the Global Deployment tile on the homepage.

GLOBAL WORKFORCE

The Global Deployment page shows employees currently available or in the process of becoming available to staff up a global project.

The world map highlights the various countries of travel, and clicking a country filters the table to only show data for that country.

The table shows those employees who are in the assessment process, have a global case in progress, or have a current visa/permit allowing them to work internationally.

GLOBAL ASSESSMENT

A global assessment lets you know the appropriate visa or work permit for your employee to work internationally. Clicking the New Travel Assessment button starts the process by first choosing a traveler or selecting traveler unknown and then filling out a travel questionnaire.

Once the questionnaire is completed, a preliminary assessment is displayed. For several common destinations, the results will show the most likely work permit or visa for that country of travel.

Until the assessment is sent for expert review, travel information can be modified via the questionnaire tab. Any modifications will automatically update the preliminary assessment.

Upon receipt of the assessment, the Global Team will review the information and return their recommendation. Once received, a global visa case can then be opened. If the Global Team recommendation is older than 60 days, however, you'll need to create a new travel assessment for that employee.

Canada - Intra-Company Transfer Work Permit
This permit is for foreign nationals who come to work for a Canadian branch of their current employer. Foreign companies with Canadian affiliates can bring executives, senior managers, and employees with specialized knowledge to work. Applicants must have worked on an ongoing basis for at least one year in the last three years for the same or a related employer. This Work Permit requires an LMA. ICT permits are generally issued in 2-3 year increments with the option to extend.
